

WEST PARKING GARAGE DIRECTIONS

FROM LEVEL ONE ENTRANCE

- ❑ **Lab Bloodwork (with port)/Infusion Area:** When you walk up the ramp to enter the West Building, the main New Patient Registration desk is in front of you. Bear to your left and go past the main entrance, the **Lab Bloodwork (with port)/Infusion Area** is on your right. You will register for your bloodwork at the registration desk in the back of the Infusion's reception area.
- ❑ **Lab Bloodwork (without port):** When you walk up the ramp to enter the West Building, the main New Patient Registration desk is in front of you. Turn right and go past the main Security Desk and the pharmacy, then up the ramp. At the top of the ramp, turn right. Check in at the first desk on your left.
- ❑ **Lab Bloodwork Area (CRU) for patients on a clinical trial:** When you walk up the ramp to enter the West Building, the main New Patient Registration desk is in front of you. Bear to your left and go past the main entrance; follow the signs for the CRU. The **Lab Bloodwork/CRU** registration area is at the far end of the hallway, past the fireplace.
- ❑ **Cafeteria (Monday – Friday, 7:00 AM – 2:00 PM):** When you walk up the ramp to enter the West Building, the main New Patient Registration desk is in front of you. Turn right past the main Security Desk and the pharmacy, go up the ramp to the 1st bank of elevators, go to the 2nd floor, turn right, and follow the hallway into the hospital straight past a nurses' station. You should begin to see large signs for the **Cafeteria** to follow. Turn left, then immediately right through two sets of double doors into the Center Building. Follow the hallway to the cafeteria, which will be on your left past the Center Building's reception desk.
- ❑ **Diagnostic Imaging:** When you walk up the ramp to enter the West Building, the main New Patient Registration desk is in front of you. Turn right and go past the main Security Desk and the pharmacy, then up the ramp. Continue past Karen's Korner Gift Shop, then turn right and then left, entering the Hospital Building. Proceed up the 2nd ramp, past a nurses' station to the 2nd doorway on the left. There is a sign above the door. Register at the desk.
- ❑ **Radiation Oncology:** When you walk up the ramp to enter the West Building, the main New Patient Registration desk is in front of you. Turn right and go past the main Security Desk and the pharmacy, then up the ramp to the next elevator on your right. Go down to the Lower Level. The radiation registration area is directly ahead as you exit the elevator.
- ❑ **Surgical Family Waiting Suite:** When you walk up the ramp to enter the West Building, the main New Patient Registration desk is in front of you. Turn right past the main Security Desk and the pharmacy, go up the ramp to the bank of elevators, and go to the 3rd floor. Turn right and follow the hallway around past the nurses' station, past an elevator to the next hallway intersection. Turn left and on your right is the door to the **the Marion and Emma Brungard Surgical Family Waiting Suite**. Please check in at the desk.
- ❑ **Medical Records:** When you walk up the ramp to enter the West Building, the main New Patient Registration desk is in front of you. Bear to the right; the West Building elevator is on your right, directly across from the main New Patient Registration desk. Take the elevator down to the Lower Level; make a left, then another left, then a right. Enter the 2nd door marked "**Medical Records**."
- ❑ **Rehab:** When you walk up the ramp to enter the West Building, the main New Patient Registration desk is in front of you. Turn right, go past the main Security Desk and the Pharmacy, and go up the ramp to the bank of elevators. Go to the 3rd floor, then turn right and follow the hallway past a nurses' station to another bank of elevators on your right. **Rehab** is located diagonally across from that elevator on the left.
- ❑ **ICU:** When you walk up the ramp to enter the West Building, the main New Patient Registration desk is in front of you. Turn right past the main Security Desk and the Pharmacy, go up the ramp and follow the hallway to the first bank of elevators. Go to the 2nd floor, turn right and follow the hallway around to the 1st nurses' station on your right. The **ICU** is on the immediate left. Check in at the nurses' station.
- ❑ **Endoscopy Suite:** When you walk up the ramp to enter the West Building, the main New Patient Registration desk is in front of you. Turn right past the main Security Desk and the Pharmacy, go up the ramp, go past Karen's Korner Gift Shop, then turn right and then left to enter the Hospital Building. Proceed up the 2nd ramp straight down the hall past a nurses' station. Just past an elevator bank and through an archway is the **Endoscopy Suite** on your right. Enter the small reception/waiting room and register.
- ❑ **Women's Center:** When you walk up the ramp to enter the West Building, the main New Patient Registration desk is in front of you. Turn right, go past the main Security Desk and the Pharmacy, go up the ramp to Karen's Korner Gift Shop, and turn right into the Young Pavilion's hallway. Halfway down on the right is the entrance to the **Women's Center**.
- ❑ **Boo's Boutique:** When you walk up the ramp to enter the West Building, the main New Patient Registration desk is in front of you. Turn right, go past the main Security Desk and the Pharmacy, go up the ramp, turn right to enter the Young Pavilion's hallway, on your right is **Boo's Boutique**, across from the Gift Shop.
